RECRUITMENT AND CANCELLATION POLICIES

FIRST USE AND DESTINATION

EXHIBITOR is obliged to make use of the area covered by this agreement for the exhibition of products or services manufactured or marketed in the day throughout the event.

SECOND ASSEMBLY , EXPOSURE , REMOVAL AND OBSERVATION OF REGULATION

EXHIBITOR manifested in this event, which will receive the Regulations Exhibition two months before the event, he knows and agrees to disseminate its contents , including its staff and / or designated and / or contract to meet your requirements or meeting their obligations , in order to meet all the guidelines set forth in this document.

THIRD TERM AND TERMINATION FORM

This shall become effective from the signing of the " Convention stands" and end on disassembly , provided that the exhibition space agreed to be delivered to the organizer on the conditions that gave and who has paid the price at 100% of it. Failure to comply with the provisions It contained in this Convention shall entitle the organizer to terminate without any liability on their part , by simple written communication this send to the EXHIBITOR , the latter must pay the first subsequent payment of damages corresponding according to the fifth Policy .

FOURTH COMPANIES DOMICILED ABROAD

FIFTH CANCELLATION

- 1) When the fault is determined ORGANIZER cancel or postpone the event date is obliged to communicate in writing to the exhibitor , who in this act agrees to conduct its exposure during the dates in due course be reprogrammed by the organizer, without any liability for this .
- 2) If for the same reasons not attributable to the organizer, this determines definitively cancel the event hereby agrees to release the organizer of all responsibility , the latter only being required to repay the full amount received from the Exhibitor amount to be reimbursed within 15 days business days following the date on which formally communicate the cancellation of the event reference in the address of the exhibitor.
